forts in efficiently managing the administration, the Ghaziabad District Magistrate Ritu Maheshwari within a short span of time has brought transmogrifying effects in the district.

She is not only managing the DM's office here, but has also walked the extra mile to handling the hefty task as Vice-Chairperson of the Ghaziabad Development Authority (GDA).

Ritu Maheshwari, a 2003 batch IAS officer of Uttar Pradesh Cadre, made visible changes in this vibrant city. Her action to ensure encroachment free Ghaziabad has been widely applauded.

Her innovative methods to check power theft during her previous stint with the Electricity department has been widely appreciated.

Before coming to Ghaziabad, Maheshwari served as the vice chairperson of the Agra development authority. Earlier, she had also served as director, medical education / health & family welfare and also held the post of district magistrate in JP Nagar, Ghazipur, Pilibhit and Shahjahanpur. She also served as vice-chairperson of the Meerut development authority, besides holding the chair of joint commissioner (Meerut).

In a country where power loss due to illegal tapping is on a high roll, Maheshwari's efforts re-iterate the need for digitization of power. Maheshwari, whose story was filed in 2014 Bollywood movie 'Katiyabaaz', was one of the leading torch bearers of the Prime Minister Narendra Modi's efforts to help out lossincurring state power depart-

Maheshwari has said that the sustainable development of Ghaziabad with special emphasis on cleanliness and greenery is her key

Excerpts from the in-

You are the District Magistrate as well as Vice-Chairperson GDA, what are the major challenges you are facing, while handling two

There are scores of challenges in Ghaziabad district. Crime remains a major challenge and to controlling them remains the top most priority of the administration. Further being neighboring district to the national capital, managing daily traffic remains another major issues. Similarly, in Ghaziabad industrial areas, where industries are mushrooming, land acquisitions and farmers issues is also a challenge. Further with high population density, maintain cleanliness and greenery in the district is another challenge for us.

When you joined Ghaziabad administration and later assured as a clean and green city, what are the steps you have taken in this regards?

I had tried to make a clean and green city, and we are working hard to provide best facilities to the Ghaziabad people. I can say a lots of work have happed in the last 7-8 months, that's creates Ghaziabad is the fastest developing city and it stood 35 position in cleanness and greenness from 350 spot as surveyed by the



government of India. We have started door-to-door garbage collections, night cleaning. Plantations have been identified in major areas all the major entry and end of the exit city. We have started special campaign 'Swachta se Samridhi ki Aur mera Ghaziabad'. With the help of Nagar Nigam, Ghaziabad Development Authority, government agencies, private bodies, and forest department and the participants of residents, we have planned 2.5 lakh plantations this year. Solid waste management is pending, lots of things to be on ground and there are must more to be done. We have been organizing 'Kachra Samadhan Mahotsav' in different parts of the city. Mahotsav will instill awareness among the people without whom no waste management and recycling pro-

gramme can be undertaken.

It will help the visitors to hone

their knowledge on various aspects of waste management and recycling that they can further put to use practically.

What are the new projects in pipeline that will further modify **Ghaziabad?**

The most important project is elevated road which is being already opened. As far for the betterment of Ghaziabad people opening of eastern phepherial expressway corridors, lots of congestation to be done to manage traffic. Metro second phase is going and expected to complete by September this year.

The proposed extension from Sector 62 to Sahibabad spans 5.11km on an elevated section with four stations in Ghaziabad – Vaibhav Khand, Indirapuram, Shakti Khand and Sector 5 of Vasundhara. The extension is estimated to cost Rs1,926 crore. This will largely cater to commuters moving from Ghaziabad city, Rajendra Nagar, Sahibabad, Vasundhara and Indirapuram towards Noida

The second extension is proposed on a 5.06km elevated corridor from Vaishali to Mohan Nagar and is expected to cost Rs 1,785 crore. This route will be an extension of the Anand Vihar to Vaishali route, which is already operational. The extension will have four proposed stations at Prahlad Garhi, Sector 14 of Vasundhara, Sahibabad and Mohan Nagar.

There are small projects like developing of parks, old plantations, developing birds watching places, traffic management schemes, lighting and sound show, pollution for IIT Roorkee and other works are on various stages. "We have also proposed in the real estate sector with majority investments coming in from private developers in the form of group housing projects, affordable housing projects, 'Pradhan Mantri Avas Yojna', malls, schools, hotels, etc. We also have proposals from the industries department as Ghaziabad is also a major industrial hub. The projects proposed by the GDA are located in Raj Nagar Extension, Indirapuram, NH-24, Koyal Enclave and Indraprastha

There has been mushrooming of illegal encroachment Ghaziabad, what actions you have taken contain them?

housing scheme areas.

We are taking necessary actions on illegal encroachment, when we find we take action on them. We freed around Rs 1400 crore land has been vacated in the last 6-7 months. We have lodged six complaints for filing FIRs against encroachers who have taken over nearly 30,210 square metres of land worth Rs Khand 4, running parallel to 126.65 crore. This is the first action against land mafias by the authority. We had earlier identified nearly 54.31 hectares of authority land that has been encroached upon. The authority has identified and named nearly a dozen persons in the six FIRs.

According to official records, of the 54.31 hectares that has been encroached upon, nearly 21.38 hectares is caught up in litigation. Of the remaining 32.93 hectares, 4.31 hectares has been freed up until now and the six FIRs were lodged in this connec-

Talking about vending zone, where a space is being provided to relocate the roadside vendors. How it is helpful and what about the development plans?

It is a government land where around 20-30 thousand vendors can be relocated in 7-8 pockets in different parts of the city. We have already relocates 3000-4000 vendors for vendor space. We are developing on the public private partnership models and we will decongest the city and proper amenities would be provided for their liveli-

We have identified four locations in Indirapuram to set up vending zones to accommodate hawkers and vendors that at present encroach upon streets and roads in the town-

Around 1,000 street vendors have been identified for whom alternate space will be provided within the township.

Though we have identified 1,000 vendors we have identified space that can accommodate over 1,100 vendors. Four vacant parcels of land in Indirapuram will be used for setting up the vending zones. The green belt in Shakti

the Hindon Canal, which had recently been cleared of illegally operating banquet halls and farm houses is one of the four locations set up for vending zones. An 800 sqm plot of land near Shanti Gopal Hospital in Ahimsa Khand 2 is another plot identified for a vending zone. In addition, two parcels of land near the sewage treatment plant along CISF-Vasundhara Road will also be used to accommodate vendors. A total of 500 vendors will be accommodated separately on the two vending zones near the STP

You have taken a great initiative to stop power theft in Kanpur, what was the action and how far it was successful?

We have taken strict action against the people who is using using illegally power theft. FIRs have been registered against the persons who are misusing the electricity. We had instructed the power corporation officials to fulfil the objective of providing 100 percent power supply in rural and urban areas of Ghaziabad. We have organized to publicise the programme of the government to provide electricity to every home and for this purpose assistance at the local level starting from Gram Pradhans, councillors and others should be taken. We have also distribute LED bulbs at these many places. Ghaziabad is the first district where is 100 percent electric supply happened.

The DM also inspected data on line losses and said that these should be curbed. Those employees who fulfil the conditions of recovering highest revenue and minimizing line losses would be rewarded, the DM remarked. She also asked the officials to put an end to power thefts.

After this, Congress Party's metropolitan president Mukesh Yadav described the drastic increase in the cost of petrol diesel as cruel joke with the common public. Party's metropolitan spokesman Pawan Sharma said that when elections were held in Karnataka, then the price of oil was not increased for 19 days. This was done only to win elections by fooling the public. After that, the central government has continued to loot the common people by increasing the price.

No let up in heat wave conditions in Haryana, Punjab

There was no let up in the heat wave conditions in Haryana and Punjab on Thursday, with Hisar once again recording the highest temperature of 45.6 degrees Cel-

Haryana's Hisar district was the hottest place in the two states and its maximum temperature was four degrees above the normal, a report by the India Meteorological Department (IMD) said.

Among other places in Haryana, Narnaul recorded a high of 44.5 degrees Celsius, three notches above the normal. Bhiwani too sizzled at 43.4 degrees Celsius.

Karnal and Ambala sweltered as the mercury touched 42 and 42.6 degrees Celsius respectively, four degrees above the normal for both.

In Punjab, Patiala and Ludhiana had a hot day at 43.1 and 42.6 degrees Celsius respectively, while Amritsar recorded a high of 41.8 degrees Celsius.

Chandigarh, the common capital of the two states, recorded a maximum temperature of 41.8 degrees Celsius, four degrees above the normal.
