Rapper Sean 'Diddy' Combs loses bid to get out of jail prior to sentencing

NEW YORK. (AGENCY) Sean "Diddy" Combs on Monday lost his bid to be released from jail ahead of his October 3 sentencing, despite a jury having found the hip-hop mogul not guilty of the most serious charges at his sex crimes trial. Combs' lawyers had asked US District Judge Arun Subramanian on July 29 to release Combs on \$50 million bond, saying conditions at the Metropolitan Detention Center in Brooklyn were dangerous and other defendants convicted of prostitution-related charges similar to Combs' were usually released before sentencing. President Donald Trump unleashed his fury about weakness in the labour market on Friday, saying without evidence that the data were "rigged" and that he was firing the Senateconfirmed department of labour official responsible for pulling together the numbers each month. In a long post on social media, Trump said he had directed his team to fire Erika McEntarfer, the commissioner of the Bureau of Labour Statistics, who was confirmed on a bipartisan basis in 2024.

Emily Liddel, an associate commissioner for the bureau, confirmed late on Friday that Dr McEntarfer had been fired and that William Wiatrowski, the commissioner, would serve as acting commissioner. The President fired Dr McEntarfer after the bureau released monthly jobs data showing surprisingly weak hiring in July and large downward revisions to job growth in the previous two months. Economists widely interpreted the report as evidence that Trump's policies were beginning to take a toll



on the economy, though the President insisted in a subsequent post that the country was "doing GREAT!"

Lori Chavez-DeRemer, the labour secretary, echoed Trump's concerns about Dr McEntarfer in a post on social media. "So you know what I did?" Trump later told reporters, as he claimed the numbers were "phony." "I fired her, and you know what? I did the right thing." Dr McEntarfer was appointed to her post by President Joseph R. CBC News had exclusive access to the Canadian effort, which delivered food supplies like lentils, oil, milk powder and pasta using a CC-130J Hercules aircraft that departed from a Jordanian airbase.
